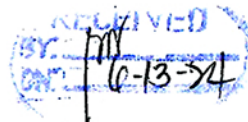

ORDER

On April 30, 2024, the court received thru email an undated Manifestation (re: Annual Members Meeting on 15 June 2024) filed by defendants and defendant Atty. Rey Nathaniel Ifurung.

In said manifestation, Atty. Ifurung informs the court that Valle Verde Country Club, Inc. will be holding its annual members meeting on June 15, 2024 since it considers the Writ of Preliminary Injunction issued on February 21, 2015 by this court to be *functus officio*.

Records show that the Writ of Preliminary Injunction dated February 20, 2015 in Commercial Case No. 14-207 has not been dissolved considering that defendants' Motion for Dissolution or Modification of the Writ of Preliminary Injunction and their corresponding Motion for Reconsideration were denied by the court.


